While in the Upper Diocese, I served on the board for Canterbury Counseling Center, as well as chaplain to Happening. I was a member of the Standing Committee and Diocesan Executive Council, as well as the Nominating Committee for the IX Bishop of Upper South Carolina. 

Personal Statement: A resident of Beaufort for nearly 25 years, I moved here to head Beaufort Academy (now retired), after 31 years as a teacher and administrator at Salisbury School. Salisbury is a fine Episcopal boarding school in the Berkshire hills of Connecticut. I spent time as Director of Development, and Assistant Headmaster.

Currently I work part-time for a consulting company in Atlanta as a Business Analyst, Facilitator and Trainer.

For most of my adult life, I lived in Atlanta, GA where I attended St. Timothy's and St. Bartholomew's Episcopal churches. My second husband was an Episcopal priest on the staff at St. Bartholomew's and while there we began & led an Anti-Racism group for the parish. In 1994, we moved to South Africa where we lived for 7 years and worshipped at St. Paul's Anglican church in Durban. In these congregations, I served in many lay positions, including lay reader, chalice bearer, vestry person, wardens, verger, stewardship chair, and others.

Seven years ago, after the death of my husband, I returned to Charleston with my 10-year-old granddaughter, Kanyisile, and we are now communicants at Grace Church Cathedral. At Grace I am currently serving on the vestry and as a lector. I am also a member and group leader of the AME-Episcopal book study which was initiated in response to the killings at Mother Emanuel and has been an educational and growing experience. And I represented our diocese at the Province IV Conversation on Racial Healing & Reconciliation at the Absalom Jones Center for Racial Healing in Atlanta 3 years ago. Last year I was appointed the co-chair of the newly formed Diocesan Commission on Racial Justice & Reconciliation. I am looking forward to working with Bishop Ruth as we begin the important & necessary work of that commission. Kanyisile has been an acolyte for many years. Last year, in response to the COVID crisis, Grace expanded its adult acolyte team to cover additional weekday services and at that time I became an adult acolyte. Kanyisile and I had the privilege of serving together for the first time as a grandmother/granddaughter acolyte team at Bishop Ruth's ordination (where Kanyisile led me!) 
